# Reinvestigate 9/11

#### The investigation that never happened.

Less than an hour after the 9/11 attacks started the Bush White House announced who the culprits were. The media never questioned it. Instead they propelled the public into a state of shock, endlessly repeating the horrifying footage.

All subsequent investigations took it for granted that the implausible official line was true: 9/11 was carried out entirely by a small band of terrorists, unknown to the authorities, so skilled that the attacks could not have been prevented.

But Richard Clarke, White House anti-terror chief at the time, recently confirmed what FBI whistleblowers have long suggested: in the weeks before the attacks the alleged 9/11 hijackers were under suspicion but senior FBI and CIA officials made a "decision": they ordered FBI field agents *not* to arrest them.

9/11 has been used to further an agenda of endless war abroad and blanket surveillance at home. Legal principles going back to Magna Carta have been shamelessly abandoned.

There are many theories about what exactly did happen, but this much is now clear. Without the stand down at the FBI and CIA the attacks could never have succeeded. And there is still no official explanation for the rapid and symmetrical collapse of three (sic) massive steel frame buildings in New York, designed to resist a collision with jetliners which took off frequently from the nearby airport.
